### **CHEER: Jasmine Kessler & Brianna Martin**

- Jasmine is working on registration for cheer competitions will have invoices soon
  - Oct 25 New Oxford
  - Nov 1 Manheim
  - Nov 8 CV
  - Nov 16 York Showdown
- Parents/cheerleaders are asking for tryouts for competition for next season
  - Running into issues with cheerleaders being forced to participate by parents and bringing the whole squad down due to lack of interest in being there
  - The board will revisit this after the season
- A lot of Midgets will not be reporting to the Labor Day weekend game
  - Per NYFC rules they need to participate in 4 weeks of sideline cheer to qualify for competition
  - If they cannot attend the 8/31 game, they will need to attend an away game
- Jasmine will be ordering pink out shirts soon working on finalizing the sizing

#### **FOOTBALL: Ross Fronk**

  - No issues during games from players or coaches
  - There were complaints about the Pony game being bumped to 3pm rather than the originally communicated 1:30pm game time

- The visiting team warmup field will be on JV practice field behind Bostic

- Nichol will have spreadsheet to Jasmine for who still owes money for cheer
- Venmo charges us 1.9 % + 10 cents charge up Brittany and Leah will work on rolling this into spirit wear costs to help offset
- Back entrance (Handicap) is cash only Tim will take care of communicating this to our visiting teams.

## **CONCESSIONS: Jeremy Wildman + Jessica Armour**

- Inventory is good
- Menu will include: hot dogs, saurkraut, chili, cheeseburgers, sausage, walking tacos, candies, chips, and beverages and a few other items
- Will need to purchase the meats yet
- Food Trucks Scheduled:
  - Week 1: Kona and Brickers
  - Week 2: Kona, Brickers, Trailer Trash \*our concession stand will not sell hot dogs\*
  - Week 3: Kona and Brickers
  - Week 4: Kona and Brickers

- Ed presented to the board having Knots & Knubs as an additional food truck at our home games
  - Jess Weber-Armour did look into this before the meeting and found that he would offer
     25% kick back to NYFC but was requesting we waive volunteer check requirements.
  - Vote by board bring to the practice field but not games due to limited space and same offerings as our concession stand. Will not be extending volunteer credit exemption.
    - Jess will reach out and make the offer
- Kona Ice will be coming to the practice fields on 8/28 and 9/4
- Current Profit to date = \$427
- Pretzel inventory will need to be bumped up at least for week #1 and #2
- Need to stress as much as we can that donations should not be turned in until the week they are due. We have limited space at the shed to store.
- Plan for water/ice for Week #1 make sure there is always a backup plan
  - Jasmine will provide them with the name of a company that should be able to donate water
  - We currently have 4 cases on hand, but will be getting more for Week #1
- Do we want to leave the register at the practice field or Nichol take it home? Nichol take home.

#### **FUNDRAISING: Mandy Nye**

- Marianna Subs and Popcorn Loft
  - o Miarianna subs will be 2-3 weeks for sales and then an additional 2-3 week turnaround
  - Popcorn loft is a similar turn around
- Do we want to run the fundraisers at the same time or alternate them?
  - May run into issues with keeping funds separate
  - Concern running them later and delivering when the season is over
- Vote by board is to run both fundraisers at the same time and kick off by first week of September
- Leah presented an opportunity through Donnie photography Yard Signs
  - \$25 a sign
  - NYFC will profit \$10 per sign
  - Voted and approved
  - Leah will handle all communications

#### **VOLUNTEERS: Jess Morret**

- Everything is going good so far
- Looking at next year, could we look at including the volunteer fee in the registration cost, and then
  offer a refund?
  - Issues with income and taxes
  - Issues with parents seeing that they already paid and will not volunteer
- Jess will provide a list to Tim of families that are refusing to provide the volunteer check this year
- Jess is working on a list of families that have not turned in a check and and comparing to families that have not signed up for volunteer slots

- Suggestion of making it so that you cannot get uniform or participate without your volunteer check turned it
- Will revisit this after the season
